Dissertation: Testing Theories of Institutional Change and Property Rights: Privatization Experiments and Economic Development Zones in China.

How do property rights change? Field research on the origins and development of privatization experiments and economic development zones in China demonstrates that marketization reforms are most likely driven by bargaining between local governments and political and economic entrepreneurs. I argue that evidence from these important cases lends credibility to general theories of institutional change that view changes in property rights as the product of changes in the bargaining strengths of local-level political and economic actors. Some of the evidence seems to support theories of change in property rights that emphasize changes in factors of market competition and the presence of local-level norms of cooperation in the development of more efficient property forms, but this evidence clearly refutes theories which emphasize changes in the reform plans and formal laws and regulations of central and provincial organs. Marketization thus largely appears to be an informal, local process.
